\*\*\*A person has to get committed to long-term care via Board of Mental Health (BOMH) and wait a long time at in-patient hospital and/or get court ordered and wait in jail in order to get into LRC or Telecare facilities. An out-patient doctor can't just do an order/referral for someone to be sent there (used to be able to).  
Many people go to Telecare as 'step-down' from LRC. They can only stay approx. 3 months then have to find community-based placement.

A doctor can make a referral for a person to go to Douglas Co. Long-Term Residential Care if they've failed all other community placement options and they aren't BOMH committed (not eligible to go to LRC), and they are Medicaid/Medicare or low-income/indigent and uninsured. To get intake process started, Call main Dg Co Services number and talk to nurse coordinator who facilitates long-term care intakes.
